- I consent to the jurisdiction of the Circuit Court of Benton County, Missouri in any suit growing out of or connected with the purchase by the undersigned of any parcel or parcels of land at any sale for taxes occurring in said county.
- I understand that the Collector may utilize various data sources to verify the accuracy of the information above and failing to fully and accurately disclose the information or signing a false affidavit may result in a voided sale.
